Ezypay-GymMaster Promotion

Terms & Conditions

These Ezypay-GymMaster Promotion Terms & Conditions form an annexure to the applicable GymMaster merchant application form and apply in addition to the Ezypay Merchant Terms and Conditions and Banking Agreement.

1. Promoter

The promoter is Ezypay Pty Ltd (Ezypay).

2. Promotion

Subject to these Terms, an Eligible Merchant will receive:

- (a) where the Eligible Merchant is located in Australia, one (1) AUD \$250 Prezzy eGift Card; or
 - (b) where the Eligible Merchant is located in New Zealand, one (1) NZD \$300 Prezzy eGift Card,
- collectively referred to as "Incentive".

3. Eligibility

A merchant is an Eligible Merchant only if it:

- is referred to Ezypay through GymMaster;
- is not an existing Ezypay merchant at the time of application;
- completes Ezypay onboarding and its merchant account becomes live, or its migration to Ezypay is completed;
- processes its first transaction through Ezypay within 90 days after the date its merchant account becomes live or its migration is completed, as applicable;
- is one of the first 50 merchants to satisfy all eligibility requirements in these Terms; and
- otherwise complies with the applicable merchant agreement, Ezypay Merchant Terms and Conditions and Banking Agreement.

4. Limit

Only one Incentive is available per Merchant Group, or per legal entity (identified by ABN or NZBN). For the purposes of these Terms, Merchant Group means all merchant accounts operated by the same legal entity or under common ownership or control.

5. Verification

Ezypay may verify whether a merchant has satisfied the eligibility requirements using its onboarding, merchant account and transaction records. The Incentive will only be issued after eligibility has been verified.

6. Delivery

Subject to eligibility verification, Ezypay will use reasonable efforts to issue the Incentive within thirty (30) days of confirming eligibility.

7. No cash alternative

The Incentive is not transferable or exchangeable and cannot be redeemed for cash by Ezypay. Use of the Prezzy eGift Card is subject to any terms imposed by its issuer or supplier.

8. Availability

The Promotion is limited to the first 50 Eligible Merchants. Ezypay may close the Promotion once that limit has been reached. Submission of an application does not reserve or guarantee an Incentive.

9. Ineligible or reversed transactions

Ezypay may withhold the Incentive where the first transaction is fraudulent, invalid, reversed, refunded, cancelled or otherwise does not constitute a genuine processed transaction. Ezypay may request information reasonably required to verify eligibility.

10. Changes or cancellation

To the extent permitted by law, Ezypay may amend, suspend or cancel the Promotion where reasonably necessary due to circumstances outside its control. Any change will not affect an Incentive already earned by an Eligible Merchant before the change takes effect.

11. Privacy

Personal information collected in connection with the Promotion will be handled in accordance with Ezypay's Privacy Policy and may be used to administer, verify and fulfil the Promotion.

12. General

If these Terms are inconsistent with the applicable merchant agreement, Ezypay Merchant Terms and Conditions or Banking Agreement, those documents prevail to the extent of the inconsistency, except in relation to the specific eligibility and fulfilment of this Promotion.

13. Final Authority

Ezypay's determination of eligibility, including whether a merchant satisfies the requirements of these Terms and whether a merchant forms part of the first fifty (50) Eligible Merchants, is final and binding, acting reasonably.
